

Live Fire Waiver and Release of Liability-Assumption and Indemnity Agreement

I HEREBY UNDERSTAND the following CAUTIONS while at the live-fire range and training areas:

- The activities involve the use of live ammunition and weapons including me, who vary levels of proficiency in the use of weapons and tactile.
- Live-fire conditions are often aggravated by the weather such as extreme heat, humidity, cold, wind or wet will increase the likelihood of physical danger & exposure to serious bodily injury, sickness, accident, or death.

I FUTHER AGREE AS A PARTICIPANT TO OBEY ALL DIRECTIONS AND INSTRUCTIONS issued during the Safety Briefing by El Dorado Sporting Clays Inc. and/or the Renter of the Facility, for the protection of the facility, staff, renter, the other participants, any observes and myself. I understand that failure to adhere to such direction may result in my immediate and complete removal from the facility and its activities.

I HEREBY ACKNOWLEDGE that any type of shooting of any type of gun (even a modified one) or the observation of this activity is inherently a dangerous activity and could result in property damage, as well as serious bodily injury or death to me and others I FUTHER ACKNOWLEDGE that nay type shooting certain risks and injuries, including but not limited to, muscle sprains and strains, tendon pulls, dislocation of joints, broken bones; injuries accompanying physical contact with other participants, and the inherent dangerous associated with the environmental conditions.

THEREFORE, I HEREBY RELEASE, WAIVE, DISCHARGE AND AGREE NOT TO SUE EL DORADO SPORTING CLAYS INC. it's facility, it's staff (the Releases), the Organization Renting the facility (named below) on the specified date below, or the instructor (if any), or any it's officers/agents. FROM ALL LIABILITY TO MYSELF, MY PERSONAL REPRESENTATIVES, ASSIGNS, HEIRS, AND NEXT OF KIN FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMAND THEREFORE ON ACCOUNT OF INJURY TO MY PERSON OR PROPERTY OR RESULTING IN MY DEATH, NOW AND FOREVER, ARISING OUT OF OR RELATED TO PARTICIPATION AND/OR INSTRUCTION IN SAID FACILITY, TRAINING COURSE, ACTIVITIES, OR ANY OTHER RELATING SHOOTING OPERATIONS THAT MAY OCCUR, WHETHER CAUSED BY THE EGLIGENCE OF THE RELEASEES OR OTHERWISE.

I HEREBY ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE, now and forever, arising out of or related to participation and/or instruction in said training course, activities, or any other related shooting operations, whether foreseen or unforeseen and whether caused by the negligence of the Releasees or otherwise, I HEREBY SEPERATELY agree to INDEMNIFY and SAVE and HOLD HARMLESS the Releasees from any loss, liability, damage or cost that they may incur, now and forever, arising out of or related participation and/or instruction in said course, activities, or any other related shooting operations whether caused by negligence of the Releasees or otherwise.

IN ADDITION, I HEREBY acknowledge that INJURIES RECEIVED MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATION OR PROCEDURES OF THE RELEASEES and agree that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, **INCLUDING NEGLIGENT RESCUE OPERATIONS** and is intended to be as broad and inclusive as permitted by the law of the State in which the activities are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall notwithstanding continue in full legal force and effect.

I have read the Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, I am aware of its legal consequence, and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me and intend my signature to be compete and unconditional release of all liability to the greatest extent allowed by law. I have had the opportunity to personally discuss with the staff of El Dorado Sporting Clays the potential dangers incidental to engaging during the shooting activities and related activities.
